5. Discussion and Possible Action re Membership Renewals

6. Discussion and Possible Action re 3-Year Wellness Subcommittee Recommendations

Ms. Ikonomov reviewed the recommendations from the Wellness Subcommittee starting with the goals, mission, strategies and key elements.

FitBits will be offered to employees who participate in the HRA to provide an opportunity for members to upgrade their devices; AzMT will be offering a \$50 subsidy.

7. Approval of 2018-19 Vendor Contract Amendments

Ms. Schulenberg reviewed the vendor renewals which will be effective July 01, 2018.

Trustee Miller made a motion to approve the 2018-19 vendor contracts as presented, seconded by Alternate Trustee Reyes and unanimously carried.

8. Approval of the 2018-19 Benefits and Rates

Ms. Schulenberg reviewed the benefits and rates from the work session meeting which included:

Medical/Rx

- The assumption that approximately 7.5% of covered population would transfer their care to Mayo; causing an overall increase of 2.94%.
- Cover changes as required under healthcare reform; which resulted in a 0.06% increase.

These changes resulted in a total increase of 3% across the board to Medical/Rx premiums.

Dental/Vision

No changes were made the dental and vision plans; however, the premiums will increase by an average of 1.2% and 5.2% respectively.

Life Insurance

• Update the VTL rate schedule to avoid Table 1 straddling; this will result in minor increases to the rates, however, those are employee paid so they do not impact the budget.

Alternate Trustee Reyes made a motion to approve the 2018-19 benefits and rates as presented, seconded by Trustee Miller and unanimously carried.

9. Admin Update

Ms. Schulenberg reported on the following admin items:

- Department of Insurance Exam has concluded, and an exit interview will be scheduled with the Trust Chairman;
- Surplus/Deficit Calculation ECA will be bringing their Client Financial Services Manager to the meeting in April to go over the calculation in detail with Trustees.
